3) In case of inspected & supplied Bearings are found to be defective or failure of the Bearings, the same should be replaced with free of cost.

4) In case of inspected & supplied Bearings are found to be repeatedly failure, QC Engineer will be required to be deputed at APL, Namrup for re-inspection and for checking the root cause of Bearings failures which is to be replaced free of cost.

2. The bidder should quote their rates excluding of all taxes and duties. GST rate along with HSN code should be shown separately.

3. The Price list should be submitted along with the offer.

4. All entries in the offer must be made in English. The total amount shall be in figures as well as in words. No overwriting shall be allowed. In case of discrepancy, the rates quoted in words shall be considered to be correct. **Hand written quotation will be not be accepted / considered**.

5. **Tender Fee:** The Bidder shall furnish Tender Processing Fee for an amount of ₹. 100.00 (Rupees One Hundred) only in online mode only by Net banking/RTGS/NEFT..

6. Earnest Money Deposit (EMD):

a) The Bidder shall furnish Earnest Money Deposit (EMD) for an amount of ₹. 8,150.00 (Rupees Eight Thousand One Hundred Fifty) only in online mode by Net banking/RTGS/NEFT or Bank Guarantee (**BG**) in favour of ASSAM PETROCHEMICALS LIMITED payable as earnest money as per the APL format (Annexure-1) along with the offer. 31. **Cancellation of Tenders:** APL reserves the right of rejection any or all bids or accepting any bid in part, without assigning any reason there off and without any financial implication on APL, What so ever.

32. GST TDS deduction from bill: With reference to the provision of Section 51 of GST, an amount equivalent to 2% (1% CGST, 1% SGST or 2% IGST) of Taxable value of supply is to be deducted as GST TDS if the taxable value of a single W/O or P.O. exceeds the value of Rs. 2.50 Lakhs before GST.

33. **TDS on purchase of Goods:** As per new provision vide Sec 194Q for Tax Deduction at Source (TDS) on the purchase of goods **Income Tax will be deducted @ 0.1% on the purchases of goods, if the purchases exceed Rs 50 lacs in a financial year**. This provision is applicable w.e.f. 1st July 2021.
