#### 1) INTRODUCTION:

Assam Petro-Chemicals Limited, [herein after referred to as (APL)] a public Sector Undertaking under the State Govt. of Assam, India was set up in the year 1976 with facilities for production of Methanol plant of capacity 100 TPD based on I.C.I. Technology in the year 1986 and a new Formalin plant of capacity 100 TPD with technology from DERIVADOS, Spain which has then been revamped to 125 TPD in the year 2012. The Company has ever since been running with excellent operational and financial performances achieving capacity utilization from the plant at the level of 95 to 100% on yearly basis and consistently earning profit. The Company now intends to further expand the business by setting up a new 500 TPD Methanol Plant & 200 TPD Formalin Plant along with captive power Unit and then to go for setting up plants for downstream value added products like D.M.E, V.A.M, Polyvinyl Acetate, Polyvinyl Alcohol etc. to establish itself as a major PETRO-CHEMICALS Complex in the region. Assam Petro-Chemicals Limited is located about 67 KM from Dibrugarh, Assam.

#### 2) SCOPE OF WORK:

- 1. The scope involves appointing reputed and financially sound export agent for exporting and custom clearance of Methanol & Formalin to the Bangladesh. Hereby, they will be defined as export cum custom clearing house agent. The export agent should arrange the orders of Methanol & Formalin for APL from reputed end user companies and ensure that APL's interest is protected.
- 2. Export agent will have to make all efforts to export of APL's owned & traded products in the assigned territory of operation. Any practice which damages APL's image and reputation will result in termination of agreement/contract.
- 3. They will act as an export agent as well as clearing house agent for APL on mutually agreed terms.
- 4. Transportation from point of origin to the end user will be in their scope.
- 5. MS/HDPE drums for carrying Methanol or Formalin will be provided by them.
- 6. On behalf of APL, all the export related formalities/requirements will be handled by the Export Agent.
- 7. In case of product rejection, APL will not take back any material and they will clear all kind payment receivable to APL.
- 8. Generation, modification, correction & resolution of technical issues of Import Export Code ( IEC ) will be under their scope, if required.
- 9. Preparation of Export Documentation
- 10. Letter of Credit Consultation and documentations.
- 11. They will register with Export Promotion Councils for Registration cum Membership Certificate (RCMC)

- 12. They will Generate Certificate of Origin under preferential & non-preferential scheme (Under SAFTA).
- 13. They will register with ICE GATE.
- 14. They will generate AD code under different ports connected with Bangladesh within India through ICEGATE
- 15. They will be responsible for Generation of Shipping Bill & Bill of Entries
- 16. They will be also involved in the regularization of Exports & generation of Electronic Bank Realization Certificate (EBRC) as per RBI Norms.
- 17. They will assist on Export Data Processing and Monitoring System (EDPMS).
- 18. They will do the Custom clearing and Logistics in the ports of North East & East India connected with Bangladesh.
- 19. They will also Assist with Marine Insurance.
- 20. They will also assist in claiming of Government subsidies under DUTY DRAWBACK, RODTEP & various other schemes.
- 21. They will involve in generation of Legal Entity Identifier (LEI).
- 22. They will also conduct Training programmes with regard to preparing of various documentation required for export of Methanol and Formalin with Marketing and Finance Dept. at Namrup, Assam.
- 23. Excise Permit, Digital Locker cum GPRS Locker will be in their scope if required.

#### 3) GENERAL TERMS AND CONDITIONS FOR APL EXPORT AGENT:

- 1. Export Agent will be required to sign an Agreement / MOU with APL which will form the basis of dealing with APL. The cost of stamp papers 02 nos. each of Rs. 100/- shall have to be borne by the agent.

- 8. Supplies will be made as per APL's credit policy by RTGS/NEFT/Letter of Credit/Bank Guarantee from any Nationalized Bank. No interest is payable by APL for any advance payment received against sale order etc.
- 9. APL will make all possible efforts to supply company's products to the export agent from time to time. However, no claim can be made in case of failure to supply APL's products due to unforeseen circumstances beyond the control of APL.
- 10. APL reserves the right to review the agency agreement afresh or terminate the agency in case of change in constitution at its sole discretion.
