Prequalification bids shall be evaluated first. Only those bids, found satisfactory in terms of prequalification criteria as stipulated in the bid document, shall be considered for price bid evaluation.

Detailed tender document can be obtained from the civil Engineering Section, APL, Namrup, by submitting an application in person during office hours starting from 24/03/2017 to 06/04/2017. The requisite cost of tender document in the form of Demand Draft / Bankers Cheque in favor of Assam Petrochemicals Limited payable at Namrup, should be enclosed with the application. The same may also be deposited in cash at the cash counter of Finance & Accounts Department, APL, Namrup. Last date of submission of bid is 11/04/2017. Bids shall be received up to 11.00 AM only on the last day. prequalification Bids shall be opened at 2.30 PM on the same day i.e. on 11/04/2017.

Completed Prequalification Bids & Price Bid after being sealed in separate envelops should be placed under a single sealed cover and should be submitted at the office of the Managing Director, APL, Namrup, along with the requisite Earnest Money Deposit (EMD) in the form of Demand Draft / Bankers Cheque pledged in favor of Assam Petrochemicals Limited payable at Namrup. The Demand Draft / Bankers Cheque in respect of EMD should be placed inside the envelope containing Prequalification Bid. NIT reference number should be super-scribed on the left hand top corner of all the envelopes. No interest shall be paid on EMD.

## **ELIGIBILITY CRITERIA:**

- 1. Contractors desirous of bidding for the job should possess required experience in successfully executing jobs of similar nature for PSUs, Govt. Organizations & private sector companies during the last seven years. Here, jobs of similarnature, implies construction cum repairing of roads etc. in town ship and factory premises in various Industries as described in details in the tender document. To be eligible, the contractor should have successfully executed either one similar job having executed value of not less than 80% of estimated cost or two similar jobs, each having executed value not less than 50% of estimated cost or three similar jobs, each having executed value not less than 40% of estimated cost.
- 2. To be eligible, the contractor should have a sound financial background and average annual turnover on construction work for the last three financial years viz. 2015-2016, 2014-2015 and 2013-2014 should not be less than the amount equivalent to 100% of estimated cost.
- **3.** The contractor should be in possession of necessary manpower, tools, tackles, equipments& machineries required for carrying out the job.
- **4.** The contractor should be registered under VAT, Service Tax, Income Tax & EPF authorities. (Copy of Registration Certificate)
- **5.** Only those fulfilling the above requirements should participate in the bid.
