**Relaxation:** A relaxation of 5% in the minimum qualifying marks shall be admissible to candidates belonging to SC, ST(P), ST(H), and OBC-NCL categories.

**Monthly Stipend:** The minimum monthly stipend payable to apprentices shall be as per the qualification prescribed in the curriculum, i.e., ₹8,200/- or ₹9,600/- for ITI/Diploma holders; ₹10,900/- for Diploma in Engineering holders [as per Apprenticeship Rules (amended 2019)].

**Selection:** Selection shall be strictly on merit, determined on the basis of the percentage of marks secured in the qualifying examination, subject to verification of original documents and fulfilment of the prescribed eligibility criteria. In the event of a tie in merit or any dispute arising during the selection process, the decision of APL Management shall be final and binding.

- Selected candidates must complete their **DBT (Direct Benefit Transfer)** registration and Aadhaar seeding formalities with their respective bank accounts either prior to or during their engagement as apprentices in the Company.
